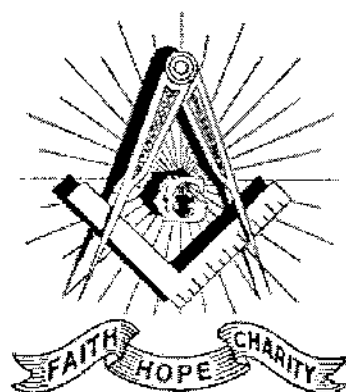

We will be putting on our **St. Patrick's day dinner on March 17th**. All you can eat for \$7, starting at 5:30 PM.

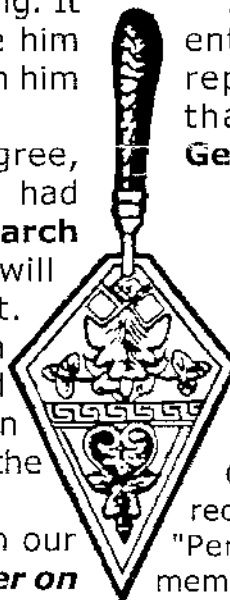

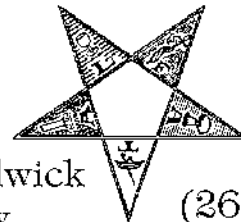

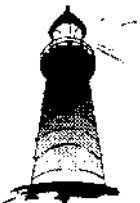
