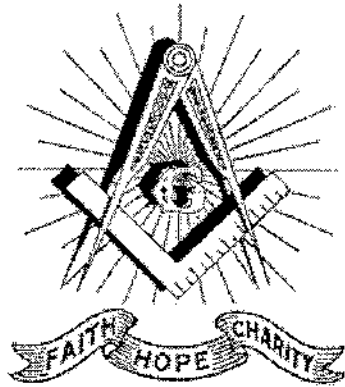

- 2) Our Trustee's are diligently working to maintain our Masonic Facility. No small endeavor.

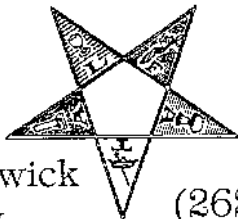

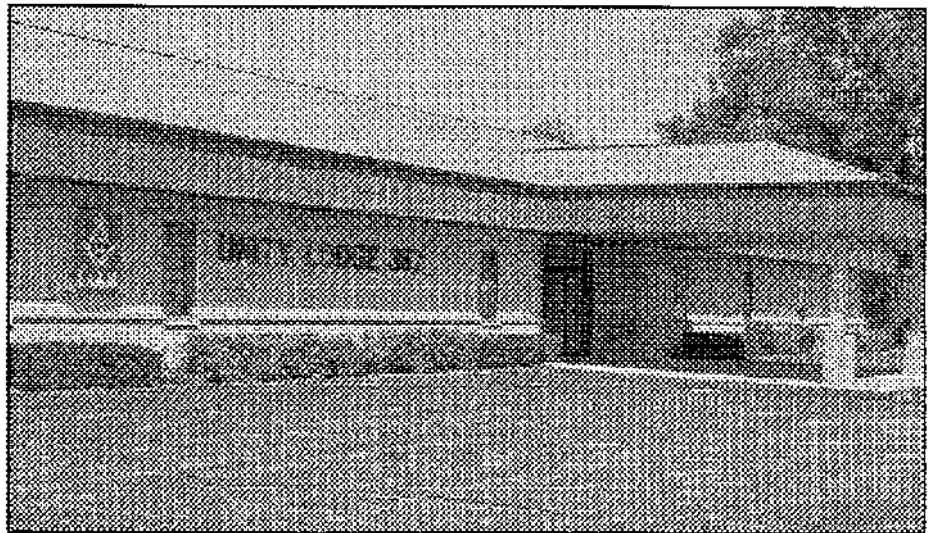
