Freemasonry on the Moon

Tomorrow marks the fortieth anniversary of the first landing on the Moon by humankind. The second man to step foot on the Moon on 20 July 1969 was Edwin E. "Buzz" Aldrin, Jr. – a Freemason from Clear Lake Lodge No. 1417 in Texas. Reportedly, Aldrin carried with him a small embroidered flag representing the Southern Jurisdiction of the Scottish Rite.
